SUMMARY: This project examined different aspects of campus crime -- specifically, the prevalence of crimes among college students, whether the crime rate was increasing or decreasing on college campuses, and the factors related to campus crime. Researchers made the assumption that crimes committed by and against college students were likely to be related to drug and alcohol use. Specific questions designed to be answered by the data include: (1) Do students who commit crimes differ in their use of drugs and alcohol from students who do not commit crimes? (2) Do students who are victims of crimes differ in their use of drugs and alcohol from students who are not victims? (3) How do multiple offenders differ from single offenders in their use of drugs and alcohol? (4) How do victims of violent crimes differ from victims of nonviolent crimes in their use of drugs and alcohol? (5) What types of student crimes are more strongly related to drug or alcohol use than others? (6) Other than drug and alcohol use, in what ways can victims and perpetrators of crimes be differentiated from students who have had no direct experiences with crime? Variables include basic demographic information, academic information, drug use information, and experiences with crime since becoming a student.

UNIVERSE: Current college undergraduates in the United States.

SAMPLING: This study was based on a national cross-sectional sample of college undergraduates in the United States. The sample was selected from AMERICAN STUDENTS LIST: COLLEGE STUDENTS AT HOME OR SCHOOL ADDRESS, published by the American List Council, Princeton, New Jersey. A sample of 6,000 student names and addresses was selected from the original list of 1,300,000. The sample size was determined by researchers to achieve a final sample of respondents that included information on at least 100 student perpetrators. Also included were respondents who participated in pilot surveys and pretests. These cases were not randomly selected, but were drawn from the student population at Towson State University, and should not be considered as part of the representative sample of current college students within the United States.

SUMMARY

This project examined the relationship between crimes committed by or against college students and the use of drugs or alcohol. A mail questionnaire administered to college undergraduates was designed to ask questions about incidents where the student was either a victim or a perpetrator of a criminal or violent act. Information on specific criminal incidents, demographic and academic characteristics of the student, and the student's drug and alcohol use was used to compare three groups: students who have committed crimes, students who have been victimized by criminals, and students who have had no such experiences.

Data were collected from April, 1989, through May, 1989, from a random sample of 6,000 undergraduate college students. There were 1,872 completed questionnaires returned during this period. Also included in this data set are three nonrandom samples of students from Towson State University used for pilot studies. There are a total of 2,207 cases from the four samples and 118 variables.

Purpose of the Study

This project examined campus crime: the occurrence of crimes among college students, whether the crime rate is increasing or decreasing on college campuses, and what factors are related to campus crime. Researchers made the assumption that crimes committed by and against college students are likely to be related to drug and alcohol use. Specific questions designed to be answered by the data include:

1. Do students who commit crimes differ from students who don't in their use of drugs and alcohol?
2. Do students who are victims of crimes differ from students who aren't in their use of drugs and alcohol?
3. How do multiple offenders differ from single offenders in their use of drugs and alcohol?
4. How do victims of violent crimes differ from victims of nonviolent crimes in their use of drugs and alcohol?
5. What types of student crimes are more strongly related to drug or alcohol use, if any, than others?
6. Other than drug and alcohol use, in what ways can both victims and perpetrators of crimes be differentiated from students who have had no direct experiences with crime.

Methods

Study Design

This study is based on a national, cross-sectional sample of college undergraduates in the United States. Data were collected through self-administered questionnaires.

Sources of Information

This research used information gathered through self-administered questionnaires sent by mail to 6,000 undergraduate students throughout the United States. Within three weeks, 1,857 completed questionnaires were returned and form the basis for this data set. Also included are data gathered from 350 additional questionnaires that were parts of three pilot studies conducted with students at Towson State University.

Sample

A random sample of undergraduate college and university students was selected from The American Students List. College Students at Home or School Address, which is published by the American List Council, Princeton, New Jersey. A sample of 6,000 student names and addresses was selected from the original list of 1,300,000. The sample size was determined by researchers to achieve a final sample of respondents that includes information on at least 100 student perpetrators.

Also included in this data set are respondents who participated in pilot surveys and pretests. These cases have not been randomly selected, but are drawn from the student population at Towson State University, and should not be considered as part of the representative sample of current college students within the United States. There are three separate nonrandom samples in addition to the randomly selected sample described in the previous paragraph. The four samples can be identified by the variable, SURVEY. To use the randomly selected sample of 1,872 respondents, researchers will be required to select only those cases coded "1" on the variable, SURVEY. Values for the other samples are 2 through 4. These other samples may appropriately be used for exploratory analyses, but not for hypothesis testing or parameter estimation.

Sample sizes for the three nonrandom surveys are: 268 cases in survey 2, 42 cases in survey 3, and 25 cases in survey 4.

Response Rates

Questionnaires were mailed to 6,000 undergraduate students. Of those, 1,872 completed questionnaires were returned within a three week period, for a response rate of 31 percent. Additionally, 346 envelopes were returned unopened because of address changes and no forwarding address.

Dates of Data Collection

Data for the random sample of students from throughout the United States were collected during April and May, 1989. The pilot data were collected earlier.

Summary of Contents

Description of Variables

The data were collected through mail questionnaires. Variables include basic

demographic information (such as date of birth, sex, and ethnic background); academic information (such as school, year in school, living arrangements, GPA, major area of concentration, and graduate school plans); drug use information (such as drugs used, including alcohol, and frequency of drug use); and experiences with crime since becoming a student (such as knowledge of crimes on campus, whether the student was ever a victim of a crime or act of violence, and if so, questions about the incident, the perpetrator, and possible drugs involved, whether the student ever committed a crime or act of violence while a student, and if so, questions about the incident, the victim, and possible drugs involved).

Presence of Common Scales

None.

Unit of Observation

The unit of observation is the individual undergraduate college student responding to the mail questionnaire.

Geographic Coverage

Data were collected on college students attending colleges and universities throughout the United States.

Evaluation

Data Quality

Checks for out-of-range values suggest that the data are relatively free from detectable coding errors. However, 40.7% of the variables had over 5% missing values. It is unclear whether these are simply inapplicable or refusals to respond to the question. Consistency checks suggest that there are very few problems other than missing data in the quality of this data set.

Data Limitations

The data set appears to contain a large number of missing data. Blanks are used to indicate failure to answer a question as well as questions that do not apply to a case. Therefore, for some variables, it is not possible to distinguish between actual missing and inapplicable responses.

While the first sample was drawn from a sampling frame representative of college undergraduates, the low response rate introduces the possibility of bias into the completed sample. Users should exercise caution, therefore, in generalizing results.

The checks in Table 5 are meant to be comprehensive, but are not necessarily exhaustive.

* Note: Two series of variables, similar in structure, lead to the high number of cases classified as missing. In the first series, the respondent was asked to check each crime from a list of which he or she has been a victim. The last item in the list was "No, I was never a victim." Each item was supposed to have been coded as 1-Yes, 2-No, blank-missing. Instead, the code 2-No was never used, and the items were coded 1 -checked, blank-not checked. Unfortunately, large numbers of students checked nothing from the list, not even the last item, "No, I was never a victim." It is therefore unclear whether the question was not answered at all, or simply that the respondent failed to notice the "No, I was never a victim" item. In these same cases, none of the follow-up questions were answered either. The second series is like the first but asks about crimes the respondent has committed. In all cases in which no items were checked in the list, we have classified blanks in the follow-up questions as missing, because we could not determine whether the respondent meant "No, I was never a victim" or failed to answer the series of items.
